OFFICE MEMORANDUM

Subject: Option of date for fixation of pay on promotion--
regarding.

In paragraph 3 of this Department O.M. No. 7/1/80-
Estt. P.1 dated 26.9.1981, on the above subject, it was
stipulated that in the event of an officer refusing promotion
after the concessions made available in that O.M., he
could be debarred from promotion for a period of one year
instead of six months as per the provisions contained in
this Department O.M. No.1/3/69-Estt(D) dated 27.11.1975.

The O.M. dated 26.9.1981 came into force from 1.5.1981.
Doubts have been raised about the application of the above
provisions to the cases of promotions occurring between 1st
May and 26th September, 1981. In the meantime this Department
has issued orders contained in O.M. No. 22034/3/81-Estt(D) dated
1st October, 1981, regarding the embargo on promotion for
one year in cases where officers might refuse promotion to
higher grades.

It is clarified that the embargo of one year will be
observed in cases of promotion arising on or after the 1st
October, 1981 and the cases falling between the 1st May and
26th September, 1981 will be dealt with in accordance with
the then existing orders on the subject.

Ministry of Finance etc. are therefore requested to
bring the above clarification to the notice of all officers
working under them for their information and compliance.


